WAITING LIST DEPOSIT AGREEMENT TERMS AND CONDITIONS

This agreement is between Lars Hindsley (Breeder) and (Prospective Buyer).

Both parties intend to participate in the sale of one authentic (T.I.C.A. registered parents) Bengal kitten once viable kittens are born. The purpose of this agreement is to guarantee the Prospective Buyer a pick placement purchase opportunity from a future litter of Bengal kittens.

Prospective Buyer will make a deposit to be held by the Breeder with the sole intent it be applied to a full deposit once viable kittens are born. At which time both parties will enter into a separate sale agreement.

NOTE: The full deposit is included in the total sale price of the Bengal kitten.

This agreement stipulates the terms of which a **Waiting List Deposit** is held by Breeder, will be applied towards a sale, and conditions of re-use or refund.

Lars Hindsley operates Iconic Bengal Cattery from: 123 Woodshade Drive, Newark, DE, 19702. By signing this agreement, both parties agree any legal matters related to this agreement will be settled in a New Castle County, Delaware court of law.

WAITING LIST DEPOSIT AGREEMENT TERMS AND CONDITIONS

SECTION 1: WAITING LIST DEPOSIT

Prospective Buyer agrees to place a waiting list deposit of \$100.00. The deposit is held by the Breeder with the sole intent it be applied to a full deposit once viable kittens are born. At which time both parties would enter into a separate sale agreement for the sale of Bengal kitten.

REFUND TERMS PRIOR TO BIRTH

The Waiting List Deposit is fully refundable prior to litter birth by written request. An estimated birth date is included below. Refunds are made within 7 business days of written request.

REFUND TERMS AFTER BIRTH

Once kitten(s) are born, the Waiting List Deposit agreement is fulfilled. The Waiting List Deposit is no longer refundable as its purpose is to withhold the Breeder from selling the kitten to any other buyers and turn away prospective sales.

If however once kitten(s) is/are born and Breeder is unable to provide the kitten due to either an expired kitten or a show quality or breeder sale occurs without warning, the full amount of the prospective buyer's deposit will be immediately refunded within 7 business days. Prospective Buyer has the option to transfer their deposit to the next litter placing Buyer in a new pick order for the next subsequent litter.
